Workshops & G2Bs - FUNCTIONING

The evening program in relation to the G2Bs, including the workshops, is subdivided into three levels and will be structured as follows:

Level 1 - One to Many (Workshop)

- •<u>Objectives:</u> To **provide general knowledge** on investment attraction programs, in general and/or specific sectors.
- <u>Execution</u>: The workshop agenda will be defined by the Ministry of Enterprise and Made in Italy and the Ministry of Investments of Saudi Arabia; the workshop will take place in the partitioned "La Scala" room and participation will be possible through registration on the "Go!" Platform or on walk-in basis.

Level 2 - One to One (G2B)

- •<u>Objectives</u>: To **provide specific information** to companies that are already interested in investing in each respective country via one-to-one meetings with the staff of the Ministry of Enterprise and Made in Italy, Invitalia and that of the Ministry of Investments of Saudi Arabia.
- <u>Execution</u>: The one-to-one government staff meetings can be requested through the "Go!" Platform or by contacting the respective organizations directly.

Level 3 - One to One (G2B)

- •<u>Objectives</u>: To **discuss specific information and goals with HEMs** (or Deputy Ministers) and high-ranking companies (at HEMs office on the first floor).
- <u>Execution</u>: The option is reserved to C-Levels only. To request a meeting, companies are required to send a formal request to **isaif2023@ambrosetti.eu**, <u>within 28th of</u> <u>August</u>, which will then be subject to Ministerial confirmation.

Kindly note that the request must include:

- Biography of Individual/s requesting to attend the meeting.
- Company profile.
- Objective/s of meeting.

B2Bs – FUNCTIONING

The B2Bs, which will take place concurrently to the G2Bs and G2B Workshops, offer a valuable chance for bilateral networking.

Execution: The B2B meetings are to be organized by the participants through the "Go!" platform as they see fit, via on-platform requests sent from one participant to the other. This will be possible once the participant has received their registration details from Confindustria.
